Glossary

Associate Partners (APs)

Associate Partners (APs) are stakeholders, for example in the public sector, policy makers, and the creative and cultural sectors, who may provide significant added value and valuable insights to the CRP from the user's perspective. They can be included in the proposal in a collaborative and advisory capacity to help explore the knowledge exchange potential of the proposed research.

Collaborative Research Project (CRP)

A Collaborative Research Project (CRP) must comprise at least **four Principal Investigators**, each based in an eligible university or a research institute **in a different HERA JRP PS country**. Each participating researcher (e.g. senior, post-doc, Ph.D. student) must be based at an eligible institution and be considered **eligible** for funding by the funding organisation of the HERA JRP PS country where he/she works. Each CRP proposal can apply for research funding up to a maximum amount of 1 M€ (across all partners) and must be between 24 and 36 months in duration.

Each project team should strive to include researchers at different stages in their careers, including postdoctoral and Ph.D. students, as Project Members. To stimulate knowledge exchange outside the academic community the inclusion of Associate Partners is encouraged. In addition, consortia are encouraged to take equality and diversity dimension issues into consideration.

The project must be balanced in terms of contributions from the four or more partners based in four or more different countries but distribution of funding over countries may be uneven.

Cooperation Partners (CPs)

A HERA CRP consortium may comprise researchers from non-HERA JRP PS countries in the form of Cooperation Partners in order to strengthen the research capacity of the consortium. Note that Cooperation Partners may only be added to an eligible HERA JRP PS consortium and that they cannot apply for HERA JRP PS funding themselves (please see the FAQs and General and National Eligibility Requirements for more information).

Eligibility Criteria

The Outline and Full Proposals will be subjected to an eligibility check according to commonly agreed HERA JRP PS criteria and national eligibility requirements (applicable in the country where the applicants intend to receive their grants). In order to be evaluated, proposals must be:

- submitted via the online application form before the submission deadline;
- submitted by an eligible research team;
- complete and filled into the prescribed template.





HERA Network

Humanities in the European Research Area (HERA) is a partnership of a growing number of national humanities funding agencies across Europe. The main objective of HERA is to firmly establish the humanities in the European Research Area and to seriously engage the humanities in the Framework Programmes of the European Commission. HERA has been designed to deliver new levels of co-operative research policy and practice in the humanities by embarking on an ambitious programme of communication, enquiry and sharing of expertise. All HERA partners are dedicated to the establishment of best practice in funding mechanisms, the establishment of quality and impact assessment methods for humanities research, the coordination of national research programmes, the joint planning and lobbying for important humanities infrastructure initiatives and the joint selection of important humanities research priorities. HERA Joint Research Programme "Public Spaces: Culture and Integration in Europe" (HERA JRP PS)

The HERA Joint Research Programme "Public Spaces: Culture and Integration in Europe" was prepared by the HERA Network members. Please note that not all HERA Network members participate in the HERA JRP PS. The full list of the HERA JRP PS partners is available in the Call for Proposals and on the HERA website www.heranet.info. The aim of the HERA "Public spaces" programme will be to deepen the theoretical and empirical cultural understanding of public spaces in a European context. The programme has been designed to facilitate a broad range of cultural approaches to conceptualising **public space**, its structural and processual formations, and its possible outcomes in terms of integration, exclusion, disintegration, fragmentation, hybridization, amalgamation or transmission.

HERA JRP PS Board

The overall responsibility for the governance of the HERA JRP PS lies with the HERA JRP PS Board, whose membership is formed by one representative from each participating funding organisation. The HERA JRP PS Board will monitor the project selection process and the progress and knowledge transfer activities of the funded projects.

Proposal assessment and selection are the responsibility of the international, independent Review Panel. The final funding decisions are made by the HERA JRP PS Board on the basis of the recommendations of the Review Panel

The HERA JRP PS Board ensures quality control of the call process and will oversee:

- the composition of the Review Panel;
- the enforcement of procedures and guidelines during the Review Panel meetings;
- the enforcement of the conflict of interest guidelines.

The HERA JRP PS Board will send one of its members as observer to the meetings of the Review Panel, and will also appoint one Independent Observer to the Review Panel.

HERA JRP PS Handling Agency (H.A.)

The Netherlands Organisation for Scientific Research (NWO) has been commissioned by the HERA JRP PS Partners to act as HERA JRP PS Handling Agency (H.A.) managing the call and selection process.

HERA JRP PS Independent Review Panel (IRP)

Proposal assessment will be the responsibility of an international, independent Review Panel (IRP)¹. The members of the IRP are leading humanities scholars, appointed by the HERA JRP PS Board. The IRP is also expected to monitor the overall research progress of the HERA JRP PS and the funded projects.

¹ At the Full Proposal stage, in addition to IRP assessments, each proposal will also be assessed by three anonymous referees.





The IRP is established once the Call for Proposals is published. The IRP is composed of international experts. All IRP members are chosen on the basis of their expertise and scholarly excellence. The Review Panel members are appointed personally. Their names will be published on the HERA website after the Call for Proposals is formally launched as a measure of transparency. To ensure the high standards of integrity in all processes, rigorous "conflict of interest" guidelines will be followed.

As outcome of the Outline Proposal review process the Review Panel produces an advice to the HERA JRP PS Board as to which Outlines should continue to the Full Proposal stage. As outcome of the Full Proposal review process, the Review Panel produces a ranking list of the projects recommended for funding. The final funding decision lies with the HERA JRP PS Board.

Individual Project (IP)

An "Individual Project" (IP) is a research project led by a Principal Investigator (PI), based at a given host institution in a HERA JRP PS participating country and funded as part of a Collaborative Research Project (CRP). A minimum number of four Individual Projects makes up a Collaborative Research Project.

Project Leader (PL)

The Project Leader (PL) is one of the PIs and is responsible for carrying out and managing the CRP, in addition to his/her own Individual Project. The PL is a senior researcher with solid experience of managing collaborative research projects. S/he will be the contact point for the HERA JRP Handling Agency throughout the application and running phase and is responsible for communication with the other partners of his/her CRP. The PL is responsible for the intellectual agenda and coherence of the project, as well as the administrative and financial management of the complete CRP including the reporting duties.

Principal Investigator (PI)

A Principal Investigator (PI) is responsible for leading research activities at his/her institution. The PI status is not limited to researchers at any specific career stage after Ph.D., although in some countries applicants with equivalent research experience are also eligible to apply. Other researchers (senior researchers, post-doctoral researchers, Ph.D. students) can be part of the PI's individual project team as Project Members (PMs). One of the PIs will act as PL. Please consult National Eligibility Requirements for full information.

Referee (external)

A referee is an internationally recognised expert in the research field relevant to a given CRP Full Proposal. Referees are selected by the Handling Agency from a pool of scholars suggested by the HERA JRP PS funding agencies. Referees' reports will be made available (anonymously) to the applicants for their information and for rebuttal (optional). The HERA JRP PS Review Panel will rank all Full Proposals based on the referee reports and the applicants' responses to these. A list of all referees used for the international peer review will be published - unassigned to proposals - on the HERA website, once the selection process has been completed.
